- "Companies Act"), the exercise by the Directors of the Company of all the powers of the Company to purchase or otherwise acquire issued ordinary shares fully paid in the capital of the Company (the "Shares") not exceeding in aggregate the Maximum Limit (as hereafter defined), at such price or prices as may be determined by the Directors from time to time up to the Maximum Price (as hereafter defined), whether by way of: (a) market purchase(s) on the Singapore Exchange Securities Trading Limited (the "SGX-ST"); and/or (b) off-market purchase(s) (if effected otherwise than on the SGX-ST) in accordance with any equal
 - access scheme(s) as may be determined or formulated by the Directors as they consider fit, which scheme(s) shall satisfy all the conditions prescribed by the Companies Act, and otherwise in accordance with all other laws and regulations and rules of the SGX-ST as may
- for the time being be applicable, be and is hereby authorised and approved generally and unconditionally (the "Share Purchase Mandate"); (2) unless varied or revoked by the Company in general meeting, the authority conferred on the Directors

 - purchase price (which shall not be more than the Maximum Price calculated on the foregoing basis) for each Share and the relevant terms of the equal access scheme for effecting the off-market purchase; "Maximum Limit" means that number of issued Shares representing 10 per cent of the issued ordinary share capital of the Company as at the date of the passing of this Resolution; and "Maximum Price", in relation to a Share to be purchased or acquired, means the purchase price
 - (excluding brokerage, commission, applicable goods and services tax and other related expenses) which shall not exceed: (a) in the case of a market purchase of a Share, 105 per cent of the Average Closing Price of the Shares; and
- (b) in the case of an off-market purchase of a Share pursuant to an equal access scheme, 110 per cent of the Average Closing Price of the Shares; and (4) the Directors of the Company and/or any of them be and are hereby authorised to complete and do all such acts and things (including executing such documents as may be required) as they and/or he may consider expedient or necessary to give effect to the transactions contemplated and/or

 2. Directors' fees payable to Messrs. Lim Chee Onn, Low Huan Ping, Ganen Sarvananthan, Arthur Seet Keong Hoe, Teo Soon Hoe and Yusof Annuar Yaacob will be paid to the relevant shareholder (namely, Keppel Telecoms Pte Ltd, SPH Multimedia Private Limited or SunShare Investments Ltd, as appropriate) that nominated each of them.
- 3. Ordinary Resolution 11 is to authorise the Directors to offer and grant options under the Scheme and to allot and issue shares pursuant to the exercise of such options under the Scheme up to an amount not exceeding 10 per cent of the issued share capital of the Company m time to time.

 4. Ordinary Resolution 12 is to empower the Directors from the date of the Annual General Meeting until the date of the next Annual General Meeting to issue further Shares and Instruments in the Company, including a bonus or rights issue. The maximum number of Shares which the Directors may issue under this Resolution shall not exceed the quantum set out in the Resolution.

 5.
